#### **Charlize León Mata** Student. Yale Univeristy *NFTE Class of 2020*

Charlize León Mata is a first-generation student originally from the Dominican Republic, but presently lives in the New York Metro Area. She is currently a rising senior at Yale University, double majoring in

Ethnicity, Race, and Migration and History of Science, Medicine, and Public Health, with an Advanced Language Certificate in Spanish. Passionate about the intersection of public health, law, and social equity, Charlize plans to pursue a career in law to advocate for historically marginalized communities.

Charlize's entrepreneurial journey began as a high school student when she created Gifting Bites, a mobile app designed to connect food businesses with nonprofits to reduce food waste and fight food insecurity. Her innovative pitch won first place in the NFTE New York Metro Youth Entrepreneurship Challenge in 2020 and earned her the national runner-up title. Now, as a NFTE alumna and judge, Charlize is excited to support the next generation of changemakers.

Though she is no longer actively pursuing Gifting Bites, Charlize remains deeply engaged in food justice and community work. She served two terms as an AmeriCorps Emerging Leaders member, mentoring youth and implementing local public health initiatives, and currently sits on the board of Haven's Harvest, a New England-based nonprofit dedicated to reducing food waste through food recovery.

At Yale, Charlize is a campus leader and advocate. She is the co-founder and co-president of Yale Lawtinas, the university's first pre-law organization for Latinas, and has served as a peer liaison for La Casa Cultural, a project lead for the Yale Hunger Project, and a Matriculate College Fellow.

Charlize is a proud Jack Kent Cooke Scholar, LEDA Scholar, Elk Scholar, and Yale President's Public Service Fellow. This summer, she will be interning in the chambers of Hon. Peggy Kuo at the U.S. District Court for the Eastern District of New York as a Sonia & Celina Sotomayor Judicial Fellow. Marissa Y. Thus motivated, she became actively involved in local government, serving as an appointed member of Manhattan Community Board 11, first as Treasurer and later as Chair of the Economic Development and Culture Committee.

Marissa's leadership and dedication to community advocacy has earned her recognition as a City & State Nonprofit Trailblazer and in 2020, she became an Alumna of the Coro Leadership New York program (LNY). She currently serves on the board of Network for Teaching Entrepreneurship and was recently appointed to the board of Hearts to Homes. Her broad engagement also includes contributions to the NYC Imagine Awards Steering Committee, the NYU Entrepreneurship Alumni Network, the Temple University NY Alumni Association, and the Tau Omega Chapter of Alpha Kappa Alpha Sorority, Inc.

She holds a Bachelor of Arts in Marketing from Temple University, a Certificate in Survey Research from the University of Connecticut, and a Master's in Public Administration from New York University.
